Johnny spent 20 years at the Sister Bay Bowl until starting his own restaurant, Johnny G's, in Sister Bay. A beloved father of 4 children – Jordan, Dana, Lauren and Will – Johnny played County League baseball, softball, broomball, golf and loved to fish no matter the season. He fished for walleye at midnight in July and northern pike through the ice in January. Johnny passed away in March 2001 doing what he loved – ice fishing – at age 41.
