Discretionary Funds



By giving to a Discretionary Fund, you can target your gift to address the needs in Door County that are most important to you. Your gift is endowed and provides a permanent source of income to be granted to community organizations that are truly making a difference in Door County. You can give to one of the Community Foundation's established funds, or create a new one in your family's name that will supports the causes important to you, literally forever.

How it works

- You identify an area of personal interest as broad or narrow as you wish.
 You can give to one of the Community Foundation's established funds
 (Children & Youth Fund, Arts Fund, Green Fund, Education Fund, Health & Human Needs Fund, or Historic Preservation Fund) or create your own Fund focused on the community issues that are most important to you.
- If you're establishing your own Community Impact Fund, it can be named to honor your family, business, or anyone you designate.
- You make a gift to the Door County Community Foundation during your lifetime, though a bequest in your will, or through your estate plans. You can give cash, appreciated stocks, real estate, or other assets.
- You qualify for the maximum tax deduction as allowed by law in the year your gift is made.
- Our Board and professional staff evaluate the community's needs and awards grants to charities in Door County. If you've established a Community Impact Fund in your family's name, grants will forever be distributed in the name of the Fund you have created.
- Because your gift is endowed, all future earnings become a permanent source of community capital, forever doing good work in Door County.

Charitable Legacy

Discretionary Funds offer donors the best of both worlds - the opportunity to choose a broad area that interests them (such as children, the arts, or the environment) while relying on the Door County Community Foundation to identify the organizations that will make the greatest impact on that issue.

One generous example is John and Nell Herlache of Sturgeon Bay. They established the John and Nell Herlache Community Fund. Each year new grants will be made in the Herlache family name to programs which address the issues John and Nell care about the most.

"This is a wonderfully effective way to give back to the place we love so much," says John and Nell Herlache. "You can create a Discretionary Fund in your own family's name - just like we did - that will forever give back to Door County."
